Suspension of Work Closures for Upcoming Washington Nationals Home Games

Per Mayor's order 2012-57, the District Department of Transportation (DDOT)'s Public Space Regulation Division (PSRD) is reinstating the Suspension of Work in the public space for construction-related activities within the boundaries surrounding the Washington Nationals stadium during home games. This suspension includes three-hour project site closures before a stadium event or baseball game, through two-hour closures after a stadium event or baseball game.

Beginning Monday, April 1, 2024, and effective every scheduled home game, lane closures and work zones will not be allowed for non-emergency work in roadways, alleys, and sidewalks in the District's right of way (within designated boundaries). This includes manhole access, construction-related deliveries and/or temporary pedestrian travel paths in the vicinity of the special event must remain open to pedestrian traffic.

SIDEWALK CLOSURES OR OBSTRUCTION IS STRICTLY PROHIBITED.

Please review Washington Nationals 2024 schedule for affected dates/times. The designated boundaries include:

4th Street SW through 8th Street SE

east/west

• SE/SW Freeway down through Frederick Douglas Memorial Bridge (Anacostia River) north.

north/south

There will be **NO exemptions** throughout this suspension of work.
