## Suspension of Work in the District of Columbia

### Indigenous Peoples' Day Monday, October 14, 2024

In observance of Indigenous Peoples' Day and pursuant to section 103.01 Article 17 item C of the District's Standard Specifications for Highways and Structures, there will be a suspension of work in the District from 12 a.m., Monday, October 14, 2024. Lane closures and work zones will not be allowed for non-emergency work in roadways, alleys and sidewalks within the District's right of way. This includes manhole access and construction-related deliveries.

**Approved public space activities may resume Tuesday, October 15, 2024, during permitted working hours.**

Per the District Department of Transportation's standard practice, exemptions will be allowed for cause in limited cases during this suspension of work. Exemptions must be requested by Friday, October 4, 2024. Exemption requests must be made in writing via email to the Chief Inspections and Enforcement Officer Ms. Stacey Collins at [stacey.collins@dc.gov](mailto:stacey.collins@dc.gov), with the following subject line, "2024 Indigenous Peoples' Day Exemption Request."

The exemption request must include the following information:

- Public space permit number for the work zone, including construction and occupancy permits
- Location of work zone
- Days and hours for the exemption
- Nature/phase of work taking place during exemption
- Basis/rationale for the exemption
- 24-hour emergency contact name, phone number, and email address
