Distribution of 2023 Commercial Vehicle Annual Tags Begins October 16

Washington, D.C. – The District Department of Transportation (DDOT) will begin distributing the **2023 Commercial Vehicle Annual Tag Permits** on Monday, October 16, 2023. These permits, initially delayed due to manufacturer error, provide commercial vehicles access to streets throughout the District of Columbia in a safe and efficient manner. This year's Annual Tags will be the same color as the ones issued in 2022.

Authorized and approved applicants for the 2023 Commercial Vehicle Tags will have their 2023 tags mailed to the address of record. DDOT will not accept walk-ins but will provide appointments to applicants who prefer to pick up their tags in person. Applicants should note the following conditions:

- Permits will be effective from Monday, October 16, 2023, and will be valid until the following dates:
 - **April 30, 2024: Tractor Trailers**
 - **June 30, 2024: Dump Trucks**
- Both new and renewed applications submitted before October 16, 2023, will be subject to the full price for the tags. These customers have been permitted to operate on expired tags during the entire period since 2022 without any lapses of service or availability.
- Applications submitted on or after October 16, 2023, will incur prorated charges for the duration of the tags.
- The Metropolitan Police Department will enforce these tags after a 30 -day warning period
