## Suspension of Work in the District of Columbia

**Veterans Day**  
**Monday, November 11, 2024**

In observance of Veterans Day and pursuant to section 103.01 Article 17 item C of the District's Standard Specifications for Highways and Structures, there will be a suspension of work in the District on Monday, November 11, 2024 to mark the Veterans Day holiday. **Lane closures and work zones will not be allowed for non-emergency work in roadways, alleys and sidewalks within the District's right of way.** This includes manhole access and construction-related deliveries.

Approved activities may resume Tuesday, November 12, 2024, during permitted work hours.

Per the District Department of Transportation (DDOT)'s standard practice, exemptions will be allowed for cause in limited cases during this suspension of work. Exemptions must be received no later than Monday, November 4, 2024, for consideration, in writing, via email, to Stacey Collins, Chief Inspections and Enforcement Officer, at [stacey.collins@dc.gov](mailto:stacey.collins@dc.gov). Please use the following subject line in your email, **"2024 Veterans Day Exemption Request."**

The exemption request must include the following information:

- Public space permit number(s) for the work zone, including construction and occupancy permits
- Location of work zone
- Day(s) and hour(s) for the exemption
- Nature/phase of work taking place during exemption
- Basis/rationale for the exemption
- 24-hour emergency contact name, phone number, and email address
