DDOT's Public Space Regulation Division will be Closed Tuesday, June 17, 2025

Washington, D.C. — The District Department of Transportation (DDOT)'s Public Space Regulation Division (PSRD) will be closed on **Tuesday, June 17, from 8:15 a.m. to 4:45 p.m.** for internal professional development. The closure affects PSRD's Occupancy Permits Branch at 1100 4th Street SW, 6th Floor; and all other branches at 250 M Street SE.

Public space services are available 24 hours a day, as customers seeking public space permits can apply for them on the <u>Transportation Online Permitting System (TOPS</u>). These customers can print out their public space permits, and Emergency No Parking signs at the following <u>kiosk locations</u>.
